Survey Background, Methodology, and Results

The SUNY Student Opinion Survey (SOS) Project

The SUNY SOS Project periodically collects background, attitude, and opinion information from samples of students – particularly undergraduate students – to explore and assess the following.

- College impressions and plans
- Satisfaction with services, facilities, and environment
- Perceived college outcomes
- Frequency of selected academic experiences
- Extent of campus contributions to student growth/preparation

In the spring of 2018, as part of a continuing effort to study the quality of student life on campus, the SUNY Office of Institutional Research and Data Analytics led the system's institutions in a cooperative research effort to assess students' impressions of their college education. The 2018 project was the twelfth in the series of survey projects; earlier projects were conducted in 1985, 1988, 1991, 1994, 1997, 2000, 2003, 2006, 2009, 2012, and 2015.

At each participating institution, a local campus coordinator was responsible for working with ACT to administer the survey. ACT coordinated instrument design and production and prepared detailed summary reports, composite reports, institutional graphics reports, and comparison reports.

Survey Methodology

The Survey Instrument. In 1985 and 1988, the ACT *Student Opinion Survey* was used for the stateoperated colleges and the ACT *Student Opinion Survey (2-Year College Form)* for the community colleges. Use of the standard ACT instruments allowed SUNY the advantage of having national norms available for all items. However, because two somewhat different survey forms were used, comparisons between SUNY's community colleges and state-operated institutions were not possible for certain items of interest. As the project grew in scope, SUNY administrators decided that a unique SUNY instrument, with additional and modified items, was needed. In 1991, SUNY directed ACT to prepare the first edition of the *SUNY Student Opinion Survey* (SUNY SOS). In 1994, at the request of SUNY personnel, ACT modified the instrument and SUNY institutions administered this new edition in both 1994 and 1997. In 1999, additional modifications were made to the SUNY SOS, and the third edition was administered in the spring of 2000.

In 2003, two new versions of the instrument were developed: SUNY SOS Form A for state-operated institutions and SUNY SOS Form B for community colleges. The 2003 instruments contained some common item sets as well as items that pertained, primarily, to the state-operated institutions or community colleges. Also in 2003, a random response check item was embedded in each instrument to allow for quality control.

In 2006, the two versions of the SUNY instrument developed in 2003 were again updated to reflect the emerging needs of the System. A random response check item was again embedded in each instrument; at the direction of SUNY System officials, records for those students who chose an inappropriate response (i.e., Very Satisfied through Very Dissatisfied) to the random response check item were eliminated from all analyses and from the data files provided to the institutions. That year,

participating institutions had the option of administering either paper-and-pencil copies of the instruments or an online version developed by ACT and posted on its web site.

In spring 2009, the version of the instrument designed for state-operated institutions was again updated; the System's community colleges deferred their participation until spring 2010. Relatively few changes were made to the basic content of the instrument, but an item was added to collect a student signature granting permission to use the student's ID or Social Security number, if provided. A random response check item was again included and individuals who failed to correctly respond to this item were eliminated from all analyses and data files. As in 2006, institutions had the option of administering either paper-and-pencil copies of the survey form or an online version prepared by ACT.

For 2012, the survey instrument for state-operated colleges was again updated by a committee of individuals from several SUNY institutions; the system's community colleges deferred their participation until spring 2013. Few changes were made to the basic content of the instrument; a student ID and signature granting permission to use the ID were again included. As in previous years, a random response check item was included, and responses from students who provided incorrect responses to this item were eliminated from all analyses. Participating institutions again had the option of administering either paper-and-pencil copies of the survey form or an online version prepared by ACT.

Beginning in 2015, the survey instrument was offered in an online version only. Both the 2015 and 2018 versions contained revisions made by a committee of individuals from several SUNY state-operated colleges and the system administration office. In 2015, 9 items on the instrument were deleted and/or replaced, an approximately equal number were moved, and approximately 17 items were changed slightly. Updates to the instrument in 2018 were similar in scope to those of 2015 (17 items deleted, 4 added, 4 moved, 13 changed slightly). A guide to the questions presented in the instrument is provided in Appendix A.

Institution Participation. During each of the 12 tri-annual administrations of the SUNY survey, institutions have been encouraged to participate but have done so on a voluntary basis, with some colleges involved in only a few of the project years. Provided in Table F1 in Appendix F is a listing of the state-operated institutions that participated during each of the 12 project years and the number of instruments each institution returned to ACT for processing. In the spring of 2018, 27 of SUNY's state-operated institutions participated in the project, returning a total of 28,478 instruments for processing.

Survey Administration. At each participating campus, the survey was conducted online. Institutions were able to customize the instrument's introductory page (e.g., add their logo, provide special instructions) and the survey messaging.

Number of Participating Students. Table F2 in Appendix F contains a list of the SUNY institutions that administered the survey during the spring of 2018. The table also presents each institution's fall 2016 undergraduate enrollment, the approximate number of students who were asked to complete the survey (i.e., the "number of students sampled"), the number of respondents who completed surveys, each institution's survey response rate, and the number of valid cases for each institution. Note that all cases with invalid responses (Very Satisfied through Very Dissatisfied) to the random response check item were removed before reports were prepared. Only student records with responses to at least 12 of the 94 items in Sections II, III, and IV of the instrument were included in the "number of completed surveys."

Because the number of valid cases varied considerably across campuses (due to over-sampling and varying survey administration procedures), comparison groups could not be developed by simply pooling the survey records from the participating schools – some type of balancing/weighting was required to assure that no institution was overrepresented in the composite statistics. To address this issue, ACT randomly selected, from each institution's valid survey records, the "number of surveys required" (based on fall 2016 undergraduate enrollment) communicated to local campus survey coordinators by SUNY officials at the start of the project. If an institution's comparison file. All comparison group statistics were computed using these down-sampled data files (see the last column of Table F2.)

Note that, for the 2018 Comparison Reports, statistics (averages, frequencies, etc.) for <u>individual</u> <u>institutions</u> were based on <u>ALL</u> valid student records returned to ACT for processing. Down-sampling was only used to prepare the data files for the comparison groups (e.g., comprehensive sector colleges, technology sector colleges). This approach differs from that used in 2006 and earlier, when all data files, including those for individual institutions, were down-sampled for comparison purposes.

The 27 participating state-operated institutions asked approximately 145,979 students to complete surveys. Overall, 26,224 students responded, with reported institutional response rates ranging from 8% to 35%. Of the responding students, records for 2,422 were removed from the data file due to invalid responses to the random response check item, yielding 23,802 "valid" records. A total of 13,835 student records were sampled from the valid institutional records for use in preparing the comparison group data files.

Reports Provided to Your Institution

Following the processing of your institution's completed survey instruments/records, a Summary Report, based on <u>all valid</u> returned survey forms (see the second-last column of Table F2), was prepared and sent to your campus survey coordinator if requested. The report contained frequencies and percentages for your students' responses to all items, as well as item averages and standard deviations for Likert-scale items in item number order and rank order by item average. Note that records with invalid responses to the random response check item were eliminated before this report was prepared. Also note that all valid records for your institution were used to prepare both your Summary Report and the following comparison report tables for your institution.

Also, included in this document is a Graphics Report (if requested by your institution) that presents selected survey findings in a visual format. The Graphics tables enable those interpreting the results to quickly identify aspects of the school for which there are large differences between the findings for the specific school and peer institutions.

The Comparison Report (this report) supplements the other reports and contains answers to some basic questions about the project, cautions to consider when interpreting the results, and statistical comparisons of your institution's findings with those of similar types of institutions (e.g., University Centers, Colleges of Technology). The report includes the following information.

1. Institution comparisons. Your institution's item-by-item results (for Likert-type items) are ranked in relation to those of your peer institutions and among all SUNY state-operated institutions (see Appendix B.) Significance test information is also included to aid in the

interpretation of observed differences between your results and those of other, comparable SUNY institutions. Comparisons for demographic and non-Likert items, with Chi-square tests where appropriate, are presented in Appendix C.

- 2. Comparison group statistics. (See Appendices D and E.) Included in these tables are frequencies, percentages, and Likert-scale averages for the SUNY state-operated college sectors listed below.
 - 27 participating state-operated colleges
 - 4 University Centers
 - 12 University Colleges
 - 7 Colleges of Technology
 - 4 Specialized Colleges
- 3. Survey administration statistics. (See Appendix F.) Table F1 presents a history of institutional participation in the SUNY survey project, and Table F2 presents a summary by institution of sampling information, survey administration procedures, and response statistics for the 2018 project.

Factors to Consider When Interpreting Results

Before comparing your institution's results with those of other SUNY colleges and with your own results from previous SUNY SOS administrations, you should consider the following information and cautions.

Sampling and Administrative Procedures. Were your sampling procedures and response rate similar to those of the institutions and groups with which you are comparing your results? If not, the average differences you observe for Likert-type items may be due, at least in part, to differences in your sampling and administration procedures.

Respondents' Demographic Characteristics. Are the demographic and background characteristics of the comparison groups sufficiently similar to those of your institution's respondents? Large demographic differences may raise serious questions concerning any comparisons. For example, if your respondents included mostly first-year students whereas most other campuses equally sampled students from all class levels, you may need to interpret all of your inter-institutional comparisons with special caution.

Availability of Services, Programs, and Facilities. Not all participating institutions offer all of the services, programs, and facilities listed in Sections II and III of the 2018 SUNY SOS instrument. Therefore, institutional comparisons for these items should take into account availability and usage differences from campus to campus.

Wording, Format, and Context of the Survey Items. If you wish to compare your results with those for 2015 or earlier, be sure to examine copies of the instruments used during each administration. Form A of the 2018 SUNY SOS is an updated instrument with a number of important differences from earlier instruments. Additionally, this instrument is considerably different from the ACT *Student Opinion Survey* instrument that was used during the 1985 and 1988 SUNY projects. Please note that even when the survey items are identical in wording and format, student responses may be affected by different item ordering or the addition/deletion of items (context effect).

Comparison Groups. The comparative data provided for various SUNY institutional groups are based on composites of the survey records obtained independently by each of the participating institutions. Because many institutions received considerably more responses than the sample sizes recommended by SUNY System officials (see "number of records used in comparison group sample" in Table F2), ACT randomly down-sampled the data file for each of these institutions to the number of respondents in its required sample size. For the limited number of institutions that returned fewer than the required number of surveys, all valid records were included in the comparison groups (e.g., University Centers, Colleges of Technology). The Comparison Report statistics (averages, frequencies, etc.) for individual institutions are based on <u>ALL</u> valid student records returned to ACT for processing. This approach differs from that used in 2006 and earlier, when all data files, including those for individual institutions, were down-sampled for comparison purposes.

Invalid Responses. All student records with invalid responses (Very Satisfied through Very Dissatisfied) to the random response check item (Section IIIA, Item 16) were removed before reports and comparison tables were prepared.

Absolute Interpretations. The absolute magnitude of all averages should be considered when interpreting the comparative figures. For example, if your institution's satisfaction average for a particular item was 4.00 (on a 5-point scale) and the comparable SUNY institution-sector average was 4.20, your average, although slightly lower, still indicates a fairly high degree of student satisfaction. Also, reviewing the percentages of students selecting each of the response options can provide valuable information that might be missed, using only the item average.

Test of Significance. The test of significance (a two-tailed test) for each difference between item averages was based on a two-sample contrast between your institution's average and the corresponding average for the other institutions in your SUNY comparison group/sector. The test assumed that both samples were randomly selected from their parent populations and that the variability of responses (coded 5, 4, 3, 2, and 1) for the colleges involved in the comparison was roughly the same. Note that this *t*-test addressed neither the practical significance nor the appropriateness of the comparison being made. An observed difference may be statistically significant but not particularly important to your institution; other results might be important to your institution even if they are not statistically significant at a predetermined level. Also, the 2018 Comparison Reports are based on <u>all</u> valid student surveys returned by each institution. Because some institutions provided well over 1,000 completed instruments, very small differences in means are likely to be noted as statistically significant. In general, differences with effect sizes under 0.20 (differences of .15 to .20 on the Likert scales used in the SUNY survey) are considered relatively minor.

Significance Levels. Three different significance levels (.05, .001, and .00001) were used in conducting the statistical tests presented in your institution's comparative report pages. Because of the large number of statistical tests conducted, you may wish to exercise caution when interpreting differences that are statistically significant only at the .05 level. Even if the null hypotheses were all true (i.e., there were no statistically significant differences), you would expect to observe several false positives (Type 1 errors) when conducting this many significance tests at the .05 level.
